Potential Actions for LAs

- The Government has launched a call for evidence on airport business rates and this is something SASIG will respond to - we urge members to also do so (see PQ1). The current proposals will generate significant revenue to line the Treasury's pockets but will offer few benefits to LAs. Indeed, there is a danger that it might suppress the economic benefits which airport growth might otherwise have generated.

Editorial

In the run up to the end of the year, this month (8th) saw a challenge by campaign group LADACAN, over the decision to expand Luton Airport, dismissed in the High Court. This was despite the fact that the Transport Secretary's decision to allow expansion went against a Planning Inspectorate recommendation that it should be turned down. Meanwhile on 17 December, London Stansted's planning application to increase passenger numbers up to 51 million a year over next two decade and which was backed by a number of leading airlines including Emirates, Ryanair, Jet2.com and Turkish Airlines, was approved by Uttlesford District Council.

Further North, Newcastle Airport secured a new £364million five-year financing facility to refinance its bank debt and support its long-term growth ambitions. The deal includes a £20 million Green Loan to fund Net Zero Carbon initiatives by 2035 and was backed by major banks including Barclays, Lloyds, and HSBC.

The thorny issue of airport business rates has become even more thornier. These rates are set to more than double at a time when global competition for connectivity, investment and trade has never been so fierce, according to Baroness Ruby McGregor-Smith's message in her speech opening the AirportsUK Annual Conference in early December. She said the UK Government needs to do more to reduce the costs and burden on airports otherwise, actions will not match ministers' rhetoric about the role they see airports, and wider aviation, playing in driving UK economic growth.

Her message reflects the one given to air travellers towards the end of the month, urging them to prepare for soaring ticket prices as regional airports throughout the UK brace for "unprecedented" property tax increases next year. An examination of official Government figures for the Press Association has shown that regional airports are among those confronting the sharpest business rates rises of any industry in the UK during a comprehensive overhaul of property assessments that determine the levy.

A notable technology news highlight was that electric flying taxis may become available to London airport passengers from 2028. Vertical Aerospace hopes its Valo aircraft, which has a capacity for up to six passengers, can get regulatory approval in three years - with the first planned commercial routes to include airport-to-city centre connections.

This month, Heathrow Airport announced plans for a £1.3 billion investment in infrastructure in 2026 with an upgrade of Terminal 4 a core focus. Work will begin on a new multi-storey car park and upgraded check-in area in T4 which is expected to be completed in 2031.

Finally, the Secretariat would like to wish all its members a great start to the New Year and thank for your staunch support throughout the old one.

Consultations Update: Recent and current:

Recent:

CAP1616: UK airspace Change Process consultation

On 25 September, the CAA launched their UK Airspace change process consultation. This document (CAP1616) was a formal consultation setting out the CAA's proposals to modify the airspace change process. The consultation ran until 18 December 2025.

UK ETS: Regional Aviation Connectivity

On 28 October 2025, the UK ETS Authority launched a [consultation](#) to assess the impacts on regional air connectivity following the removal of UK ETS free allocation (FA) from the aviation sector. This could have material impacts on many regional and smaller airports.

The consultation sought views on whether intervention is needed to protect regional air connectivity specifically in light of the end of FA for aircraft operators, and if so, what form this should take. Ongoing:

CAA consultation: Policy framework for new types of Vertical-Take Off and Landing aircraft (6 Nov 2025 – 29 Jan 2026)

On 6 November 2025, the CAA launched [a consultation](#) seeking views from the public and VTOL industry stakeholders on their proposed legislative changes. The CAA is aiming to implement the regulatory framework and operational systems needed for commercial passenger flights by new types of vertical take-off and landing (VTOL) aircraft by the end of 2028. As such, it is in the process of identifying the regulatory changes needed to accommodate the safe use of these new types of VTOL aircraft in the UK, whilst supporting sector growth, innovation, decarbonisation and international alignment.

This consultation closes **29 Jan 2026**.

UK Airspace Design and Coordination Services (CAP3158 and CAP3159) – 17 November 2025 – 12 January 2026.

On 17 November 2025 the CAA published:

- [Consultation on draft guidance for the UK Airspace Design and Coordination Services](#) (CAP 3158); and
- [Consultation on the requirements for the UK Airspace Coordination Service and associated guidance](#) (CAP 3159).

These services are central to the Government's approach to modernising UK airspace and will be provided by NATS (En Route) plc (NERL).

The CAA have updated their background document [Modernising the way we do airspace design \(CAP 3156\)](#), which supports these consultations, and they welcome responses by **12 January 2026**.

Proposed changes to the Air Navigation Directions and Air Navigation Guidance (25 November – 20 January 2026)

On 25 November 2025, the DfT published a [consultation](#) on proposed changes to the Air Navigation Directions and Air Navigation Guidance. These two documents provide the framework and environmental guidance for the CAA on how to carry out its air navigation functions in line with Government policy.

These documents require updating to reflect the latest Government policies, priorities and climate obligations, and their revision is critical to the delivery of Airspace Modernisation. The proposed changes are intended to help futureproof UK skies in a sustainable manner, whilst supporting economic growth, including airport expansion.

Parliamentary and Government News

4 December: [Unmanned Aircraft \(Offences and Consequential Amendments\) Regulations 2025](#) (House of Lords)

Lord Hendy of Richmond Hill asked that the Grand Committee do consider the Unmanned Aircraft (Offences and Consequential Amendments) Regulations 2025.

8 December: [Unmanned Aircraft \(Offences and Consequential Amendments\) Regulations 2025](#) (House of Lords)

Lord Hendy of Richmond Hill moved that the draft Regulations laid before the House on 21 October be approved.

Relevant document: 40th Report from the Secondary Legislation Scrutiny Committee. Considered in Grand Committee on 4 December.

Motion agreed.

8 December: [Sustainable Aviation Fuel Bill](#) (House of Lords)

Lord Hendy of Richmond Hill moved that the order of commitment of Thursday 20 November committing the bill to a Grand Committee be discharged and that the bill be committed to a Committee of the Whole House; and that if the bill's Committee stage is not concluded by the rise of the House on Wednesday 10 December, the bill be reported from the Committee of the Whole House in respect of proceedings up to that date; and that, for the remainder of the bill, the bill be committed to a Grand Committee.

Motion agreed.

10 December: [Sustainable Aviation Fuel Bill](#) (House of Lords)

The Bill was debated: *Scottish and Welsh legislative consent sought, Northern Ireland legislative content granted.*

Parliamentary Questions:

Q.1. Question (95970) asked by Richard Holden (Basildon & Billericay) on 1 December 2025: “To ask the Chancellor of the Exchequer, what assessment she has made of the potential impact of future increases in business rates on the financial sustainability of regional airports and the level of regional air connectivity they are able to provide.”

A. Dan Tomlinson on 4 December 2025: “The government is committed to enabling investment so that airports can play their full role in the growth mission. Properties seeing large bill increases as a result of the business rates revaluation - including airports - will benefit from a redesigned transitional relief scheme worth £3.2 billion over the next 3 years. Compared to the 2023 transitional relief scheme, the redesigned scheme will provide more generous support for large properties. The Government has also published a Call for Evidence exploring concerns that airports and a small number of other ratepayers have raised around the ‘Receipts & Expenditure’ valuation methodology and its impacts on long-term, high value investments. Through this call for evidence, we will seek to address issues raised ahead of the 2029 revaluation”.

Q.2. Question (95835) asked by Ben Obese-Jecty (Huntingdon) on 1 December 2025: “To ask the Secretary of State for Transport, what assessment she has made of the impact of (a) ownership and (b) investment in Heathrow Airport by Chinese companies”.

A. Keir Mather on 9 December 2025: “The Government takes its responsibility for national security extremely seriously and balances this with its continued commitment to welcome inward investment in a way that provides investors with the certainty and transparency they need to do business in the UK. We work across government to conduct due diligence and other assessments and ensure that any potential national security risk to the UK is handled appropriately. For any new qualifying investments in sensitive sectors, which include transport, we will use the powers in the National Security and Investment Act 2021 to scrutinise transactions and intervene if necessary to protect national security”.

Q.3. Question (95934) asked by Munira Wilson (Twickenham) on 1 December 2025: “To ask the Secretary of State for Transport, how many sustainable aviation fuel plants are currently operational”.

A. Keir Mather on 5 December 2025: “I refer the hon Member to the answer I gave to the Rt Hon Member for Basildon and Billericay on 7 November 2025, to Question UIN 86750”.

Q.4. Question (95936) asked by Munira Wilson (Twickenham) on 1 December 2025: “To ask the Secretary of State for Transport, how many sustainable aviation fuel plants she expects to be under construction in (a) 2026, (b) 2027, (c) 2028, (d) 2029 and (e) 2030”.

A. Keir Mather on 5 December 2025: “I refer the hon Member to the answer I gave to the Rt Hon Member for Basildon and Billericay on 7 November 2025, to Question UIN 86750”.

Q.5. Question (97061) asked by Joe Robertson (Isle of Wight East) on 3 December 2025: “To ask the Chancellor of the Exchequer, what recent representations she has received from airport operators regarding the potential impact of business rates changes announced in the Budget on the competitiveness of UK airports”.

A. Dan Tomlinson on 11 December 2025: "The government is committed to enabling investment so that airports can play their full role in the growth mission. HM Treasury received budget submissions from several airports and AirportsUK. Both Ministers and officials have met with the sector and corresponded throughout the year on the impact of changes to rateable values as a result of the 2026 revaluation. Properties seeing large bill increases as a result of the business rates revaluation - including airports - will benefit from a redesigned transitional relief scheme worth £3.2 billion over the next 3 years. At Budget 2025, the government also published a Call for Evidence on Business Rates and Investment. It will explore the concerns that airports and a small number of other ratepayers have raised around the 'Receipts & Expenditure' valuation methodology and its impacts on long-term, high value investments. The government is seeking to address issues raised ahead of the 2029 revaluation, aiming to conclude this work in sufficient time before pre-list discussion commences.

Q.6. Question (96849) asked by Ben Obese-Jecty (Huntingdon) on 3 December 2025: "To ask the Secretary of State for Transport, what the deadline is for the submission of a development consent application for a third runway at Heathrow Airport".

A. Keir Mather on 15 December 2025: "It will be for scheme promoters to decide when to submit a development consent order application for a third runway scheme".

Q.7. Question (96848) asked by Ben Obese-Jecty (Huntingdon) on 3 December 2025: "To ask the Secretary of State for Transport, what assessment she has made of the feasibility of new terminals for the proposed third runway at Heathrow Airport being built and operated in competition with those run by the airport".

A. Keir Mather on 12 December 2025: "Information about terminals and other airport infrastructure would be provided as part of a development consent order application".

Q.8. Question (96847) asked by Ben Obese-Jecty (Huntingdon) on 3 December 2025: "To ask the Secretary of State for Transport, by what date she plans to complete the review into airport funding".

A. Keir Mather on 15 December 2025: "There is no current review into airport funding".

Q.9. Question (96481) asked by Ben Obese-Jecty (Huntingdon) on 2 December 2025: "To ask the Secretary of State for Transport, what assessment has she made of the potential impact on airline ticket prices from Heathrow Airport of the need to fund the public consultation process for the proposed third runway".

A. Keir Mather on 10 December 2025: "The Government is committed to delivering a third runway at Heathrow in a cost-effective way. The Civil Aviation Authority have launched a consultation on their working paper of regulatory options in their role as the independent economic regulator for the aviation industry. They propose several criteria for assessing future regulatory models, including how effective these options are in keeping costs for the travelling public low. Aviation operates predominantly in the private sector, with ticket prices determined by many factors including competition between airlines".

Q.10. Question (96785) asked by Richard Holden (Basildon & Billericay) on 3 December 2025: "To ask the Chancellor of the Exchequer, what assessment she has made of the potential impact of business rates increases at airports on i.) passenger ticket prices and

ii.) airline route planning”.

A. Dan Tomlinson on 11 December 2025: “The government is committed to enabling investment so that airports can play their full role in the growth mission. Properties seeing large bill increases as a result of the business rates revaluation - including airports - will benefit from a redesigned transitional relief scheme worth £3.2 billion over the next 3 years. At Budget 2025, the government also published a Call for Evidence on Business Rates and Investment. It will explore the concerns that airports and a small number of other ratepayers have raised around the ‘Receipts & Expenditure’ valuation methodology and its impacts on long-term, high value investments. The government is seeking to address issues raised ahead of the 2029 revaluation, aiming to conclude this work in sufficient time before pre-list discussion commences”.

Q.11. Question (96482) asked by Ben Obese-Jecty (Huntingdon) on 2 December 2025: “To ask the Secretary of State for Transport, what is the projected total cost of a third runway at Heathrow, including the consultation process; and who will be responsible for funding the planning and construction”.

A. Keir Mather on 10 December 2025: “The Government has been clear that any expansion at Heathrow must be affordable and firmly in the interests of passengers. The costs of the scheme, should be kept to a minimum and met through private funding, including any associated surface-transport requirements.

Whilst we have set out our ambition to move at pace, decisions on construction and operational costs are ultimately a matter for the scheme promoter. Scheme promoters are responsible for any consultation in relation to their DCO application in accordance with Planning Act 2008 requirements”.

Q.12. Question (97212) asked by Jim McMahon (Oldham West, Chadderton & Roydon) on 4 December 2025: “To ask the Secretary of State for Transport, what assessment she has made of the potential impact of Heathrow expansion on regional airports such as Manchester”.

A. Keir Mather on 9 December 2025: “Expanding Heathrow has the potential to support connections between the regions and London, and, in turn, between the UK’s regions and the global economy - giving the entire UK more access to Heathrow’s world-leading connectivity. Domestic connectivity is a key part of the Airports National Policy Statement that we are currently reviewing, and we will consult on any revisions by summer 2026”.

Q.13. Question (96341) asked by Richard Holden (Basildon & Billericay) on 2 December 2025: “To ask the Secretary of State for Transport, what assessment she has made of the potential impact of trends in the level of regional airlines and air links in the last five years on regional communities; and what steps she is taking to support the retention of regional air services”.

A. Keir Mather on 10 December 2025: “The UK aviation market operates predominantly in the private sector, and it is for airports to invest in their infrastructure to attract passengers and airlines, while airlines deliver services by responding to demand for different routes. The Aviation Council was established earlier this year as a strategic platform for Government and industry to work collaboratively on the long-term challenges and opportunities facing the UK aviation sector. The Council is co-chaired by myself, the Minister for Aviation, and Ken O’Toole, the CEO of Manchester Airport Group (MAG).

The Council has formed five working groups to look at priority areas, including a Regional Connectivity working group to understand the factors that have influenced UK regional aviation connectivity, so recommendations can be made that would encourage growth. The Government continues to provide support for existing domestic air routes which are in danger of being lost through the use of the Public Service Obligation (PSO) regulations. The Department for Transport currently joint-funds three PSO air routes into London from Newquay, Dundee and Derry/Londonderry”.

Q.14. Question (98411) asked by Jim Shannon (Strangford) on 9 December 2025: “To ask the Secretary of State for Transport, what steps she is taking to improve regional air travel”.

A. Keir Mather on 11 December 2025: “Regional airports serve our local communities and act as a gateway to international opportunities, alongside maintaining social and family ties and strengthening the bonds between the four nations. The UK aviation market operates predominantly in the private sector. It is for airports to invest in their infrastructure to attract passengers and airlines, while airlines are well placed to deliver services to their customers by responding to demand for different routes. The public service obligation (PSO) regulations enable the protection of existing domestic routes that are in danger of being lost. The government currently joint-funds three PSO routes into London from Derry/Londonderry, Newquay and Dundee”.
