Editorial

The year started off with a lot of concern that airports across the UK will be hit by steep rises in business rates arising from increased property tax this year. As a result, passengers are being told to brace for a rise in ticket prices. Add to this concern and some anger at the dramatic increase in airport drop-off fees across the UK. Many hubs have updated their prices for the new year - Gatwick has now become the most expensive in the UK and London City became the last airport to completely scrap free drop-offs. There's been quite a few Parliamentary questions about this issue this month, with some of the questions included in our Parliamentary Questions section. Do take a look.

Now one for our drone enthusiasts! Amazon got the go-ahead to deliver by drone (10 Jan). This approval will see parcels dropped into customers' gardens in the area around Darlington, County Durham. We will keep an eye out for further updates for members.

Heathrow still continues to dominate industry news as on 11 January its boss called for faster runway approval from Government to meet the 2029 start date and the airport formally began its planning application for the project.

Gatwick was also in the news again this month: on 20th communities around the airport and industry stakeholders were invited to have their say on Gatwick's Route 4 Airspace Change Proposal and the High Court was told by campaigners that the climate impact of a second runway at Gatwick was not properly assessed when the government approved plans.

To the north, details emerged that Newcastle Airport had secured a £364 million finance package refinancing existing facilities and supporting growth and sustainability targets. The package includes a £20 million green loan dedicated to projects aimed at achieving net zero carbon status by 2035.

And finally, even more north - north of the border in fact - on 13th Scotland's SNP Government revealed that wealthy individuals using private jets to fly across Scotland will be hit with a new environmental tax and later in the month on the 29th they then launched a consultation (running until 26 March) seeking views and evidence on the implementation Air Departure Tax.

Consultations Update: Recent and current:

Recent:

[**CAP1616: UK airspace Change Process consultation**](#)

On 25 September, the CAA launched their UK Airspace change process consultation. This document (CAP1616) was a formal consultation setting out the CAA's proposals to modify the airspace change process. The consultation ran until 18 December 2025 and SASIG submitted a response.

[**UK ETS: Regional Aviation Connectivity**](#)

On 28 October 2025, the UK ETS Authority launched a [consultation](#) to assess the impacts on regional air connectivity following the removal of UK ETS free allocation (FA) from the aviation sector. This could have material impacts on many regional and smaller airports and for that reason.

The consultation sought views on whether intervention is needed to protect regional air connectivity specifically in light of the end of FA for aircraft operators, and if so, what form this should take. The deadline for responses was 19 December 2025.

[CAA consultation: Policy framework for new types of Vertical-Take Off and Landing aircraft \(6 Nov 2025 – 29 Jan 2026\)](#)

On 6 November 2025, the CAA launched [a consultation](#) seeking views from the public and VTOL industry stakeholders on their proposed legislative changes. The CAA is aiming to implement the regulatory framework and operational systems needed for commercial passenger flights by new types of vertical take-off and landing (VTOL) aircraft by the end of 2028. As such, it is in the process of identifying the regulatory changes needed to accommodate the safe use of these new types of VTOL aircraft in the UK, whilst supporting sector growth, innovation, decarbonisation and international alignment.

This consultation closed on 29 Jan 2026.

UK Airspace Design and Coordination Services (CAP3158 and CAP3159) – 17 November 2025 – 12 January 2026.

On 17 November 2025 the CAA published:

These services are central to the Government's approach to modernising UK airspace and will be provided by NATS (En Route) plc (NERL).

The CAA have updated their background document [Modernising the way we do airspace design \(CAP 3156\)](#), which supports these consultations, and they wanted responses by 12 January 2026.

Proposed changes to the Air Navigation Directions and Air Navigation Guidance (25 November – 20 January 2026)

On 25 November, the DfT published a [consultation](#) on proposed changes to the Air Navigation Directions and Air Navigation Guidance. These two documents provide the framework and environmental guidance for the CAA on how to carry out its air navigation functions in line with Government policy.

These documents require updating to reflect the latest Government policies, priorities and climate obligations, and their revision is critical to the delivery of Airspace Modernisation. The proposed changes are intended to help futureproof UK skies in a sustainable manner, whilst supporting economic growth, including airport expansion.

Ongoing:

Transforming Business Rates

(25 November 2025 – 18 February 2026)

At Budget 2025, the Government published a Call for Evidence: Business Rates and Investment: Call for Evidence. This builds on the findings of the Transforming Business Rates: Discussion Paper and asks stakeholders for more detailed evidence on how the business rates system influences investment decisions – an important factor for airports to consider. The Government is interested in hearing from a wide range of stakeholders to support further policy development.

The Call for Evidence will be open until 18 February 2026.

Parliamentary and Government News

Transport Questions: House of Commons:

The House rose on 18 December for the Christmas Recess and returned on 5 January 2026.

13 January: Airport Drop Off Charges

Transport Questions: House of Lords

Parliamentary Questions:

Q.1. Question (102226) asked by Chris Coghlan (Dorking & Horley) on 2 January 2026: "To ask the Secretary of State for Transport, what comparative assessment her Department

has made of forecourt drop off and pick up charging practices at major international airports, including in the United States and Europe”.

A. Keir Mather on 12 January 2026: “The provision of and charging for car parking at UK airports (including drop off and pick up charges) is solely a matter for the airport operator, as a commercial business, to manage and justify. However, the Government expects car parking at UK airports to be managed appropriately, and for consumers to be treated fairly”.

Q.2. Question (102228) asked by Chris Coghlan (Dorking & Horley) on 2 January 2026: “To ask the Secretary of State for Business and Trade, if his Department will make an assessment of the potential impact of the ability of UK airports to set forecourt drop off and pick up charges without an upper limit on anti-competitive pricing for passengers and local residents”.

A. Kate Dearden on 12 January 2026: “The provision of and charging for car parking at UK airports (including drop off and pick up charges) is solely a matter for the airport operator, as a commercial business, to manage and justify. However, the Government expects car parking at UK airports to be managed appropriately, and for consumers to be treated fairly, which could include providing information on choices for parking, along with information on how to access them”.

Q.3. Question (102225) asked by Chris Coghlan (Dorking & Horley) on 2 January 2026: “To ask the Chancellor of the Exchequer, if she will make an assessment of the potential impact of increases in business rates at major UK airports on passenger drop off charges”.

A. Dan Tomlinson on 12 January 2026: “Properties seeing large bill increases as a result of the business rates revaluation - including airports - will benefit from a redesigned transitional relief scheme worth £3.2 billion over the next 3 years. At Budget 2025, the government also published a Call for Evidence on Business Rates and Investment. It will explore the concerns that airports and a small number of other ratepayers have raised around the ‘Receipts & Expenditure’ valuation methodology and its impacts on long-term, high value investments. The government is seeking to address issues raised ahead of the 2029 revaluation, aiming to conclude this work in sufficient time before pre-list discussion commences”.

Q.4. Question (102224) asked by Chris Coghlan (Dorking & Horley) on 2 January 2026: “To ask the Secretary of State for Transport, whether her Department plans to introduce (a) guidance and (b) regulation to (i) cap and (ii) limit airport forecourt drop off and pick up charges”.

A. Keir Mather on 12 January 2026: “The provision of and charging for car parking at airports (including drop off and pick up charges) is solely a matter for the airport operator, as a commercial business, to manage and justify. However, the Government expects car parking at airports to be managed appropriately, and for consumers to be treated fairly”.

Q.5. Question (102166) asked by Adam Jodge (Newcastle Under Lyme) on 2 January 2026: “To ask the Secretary of State for Northern Ireland, what discussions he has had with Cabinet colleagues on the potential impact of a rail connection to Belfast International Airport on economic growth across the United Kingdom”.

A. Matthew Patrick on 12 January 2026: “Belfast International Airport is vital not just for Northern Ireland’s connectivity but for economic growth across the whole of the UK.

While civil aviation is a reserved matter, the development of airports in Northern Ireland, and the surface transport serving them, is devolved. It is therefore for the Northern Ireland Executive to determine their infrastructure investment priorities, including any potential rail connection, within the record funding settlement for Northern Ireland announced by the Chancellor at the spending review”.

Q.6. Question (103760) asked by Jim Shannon (Strangford) on 7 January 2026: “To ask the Secretary of State for Transport, what discussions she has had with major airports on tackling noise pollution”.

A. Keir Mather on 15 January 2026: “Ministers and officials engage regularly with airports on a range of issues including noise pollution. Major airports are required to produce noise action plans every five years. Current plans cover the period 2024-2028 and have been published on airports’ websites. The government also sets noise controls at Heathrow, Gatwick and Stansted airports. At other airports, appropriate noise controls should be set locally through the planning system”.

Q.7. Question (103356) asked by Mims Davies (East Grinstead & Uckfield) on 6 January 2026: “To ask the Secretary of State for Transport, what assessment has she made of the potential impact of Gatwick Runway expansion on the local economy and the need for workers accommodation in a) the build stage and b) on the operation of the new runway”.

A. Keir Mather on 15 January 2026: “On 21 September 2025 the Transport Secretary gave approval for Gatwick Airport’s application for a Development Consent Order to expand its operations through routine use of its existing northern runway. The Transport Secretary’s consideration of the application for the development including impacts arising from it are set out in her decision letter of 21 September 2025 which is available on the Planning Inspectorate’s website”.

Q.8. Question (102882) asked by Richard Holden (Basildon & Billericay) on 5 January 2026: “To ask the Secretary of State for Transport, pursuant to the Answer of 10 December 2025 to Question 96341, what consideration her Department has given to funding Public Service Obligation air routes between UK airports which do not involve the service starting or ending in London”.

A. Keir Mather on 13 January 2026: “In December 2023, the Department for Transport published updated Public Service Obligation (PSO) guidance extending support to region-to-region PSOs which removes the historical requirement for eligible PSO routes to operate into London. Region-to-region PSOs can be used on existing routes if a route is at risk of being lost and the route meets the criteria for PSO support. These would need to be funded by the relevant local authorities”.

Q.9. Question (101788) asked by Sarah Olney (Richmond Park) on 2 January 2026: “To ask the Secretary of State for Transport, when the results of the Aviation Nights Noise Effects study will be published”

A. Keir Mather on 12 January 2026: “We expect to publish the results of the Aviation Night Noise Effects study later this year”.

Q.10. Question (104135) asked by Gareth Thomas (Harrow West) on 8 January 2026: “To ask the Secretary of State for Transport, what assessment she has made of the potential impact of a third runway on communities close to Heathrow”.

A. Keir Mather on 14 January 2026: “The Airports National Policy Statement (ANPS) sets out the mitigations a promoter must provide to minimise the impact of the project on the environment and affected communities. The review of the ANPS will consider if any changes are required to the existing mitigations. We will consult on any proposed amendments to the ANPS in summer 2026, and communities will have the chance to express their views”.

Q.11. Question (105379) asked by Lee Anderson (Ashfield) on 13 January 2026: “To ask the Secretary of State for Transport, what steps her Department is taking to support regional airports.

A. Keir Mather on 20 January 2026: “Regional airports connect all regions of the UK to national and international opportunities. They serve our local communities by supporting thousands of jobs while maintaining social and family ties and strengthening the bonds between the four nations.

The UK aviation market operates predominantly in the private sector. Airports invest in their infrastructure to attract passengers and airlines, while airlines are well placed to deliver services to their customers by responding to demand for different routes.

Ministers and officials at the Department meet regularly with regional airports to discuss issues such as regional air connectivity. Government supports connectivity through our joint funding of three Public Service Obligation (PSO) routes into London from Newquay, Dundee and Derry/Londonderry”.

Q.12. Question (107025) asked by James Cleverley (Braintree) on 20 January 2026: “To ask the Secretary of State for Housing, Communities and Local Government, how will the uplift in Rateable Values of airports in the 2026 Rating List, relative to the 2023 Rating List, affect the revenue of local billing authorities with airports in their localities”.

A. Alison McGovern on 28 January 2026: “At revaluations, adjustments through the business rates retention system ensure that as far as possible local authorities do not see a change in the income they raise from business rates. In 2026-27, the business rates retention system is being reset as part of the design of the multi-year settlement which will also deliver the Fair Funding Review reforms. The reset includes a new measurement of all local authorities’ income which takes into account the impact of the 2026 revaluation, and reallocates business rates funding according to an updated measurement of local government funding need”.
